Office of the Board of Regents

The affairs of the University of Hawai'i fall under the general management and control of the Board of Regents, pursuant to [Article X, Hawai'i State Constitution](#), and [Chapter 304A](#), Hawai'i Revised Statutes. The board formulates policy and exercises control over the university through its executive officer, the university president. The board has exclusive jurisdiction over the internal structure, management and operation of the university.

The board is composed of 15 [regents](#), who volunteer to serve without compensation, and are nominated by the [Regents Candidate Advisory Council](#), appointed by the governor and confirmed by the legislature.

The University of Hawai'i Board of Regents also serves as the State Board for [Career and Technical Education](#).
